*The Triethanolamine is used as a neutralizing agent in this product and as such is bound in the matrix of the product as a salt. This amine salt is considered essentially unreactive at room temperature. If heat is used during the drying process of the coating some amine vapors may be released.

4. FIRST AID MEASURES
