DESCRIPTION

Skid-Daddle is a specially formulated cleaner designed to remove rubber tire marks from epoxy or other polymer floor coating systems without damaging the floor coating. **Skid-Daddle** is a blend of special cleaning agents, surfactants, and terpene solvents. It has a light amber color and fresh citrus fragrance.

USES

- Clean tire marks from surfaces coated with epoxy, novalac, urethane, methyl methacrylate, or vinyl ester polymer coatings
- General floor cleaner for plain concrete or polymer coated floors to remove grease, dirt, and oil

ADVANTAGES

- Cleans black rubber tire marks caused by a variety of wheeled devices such as forklifts and skid steers without damaging polymer floor coatings
- Deep cleans dirt, oil, and grease from the pores and capillaries of plain concrete
- Neutral pH
- Pleasant clean citrus fragrance
- Does not contain petroleum solvents

Use Dilution Rate With Clean Potable Water	
1:1	Tire mark removal
10:1	Bucket Cleaning
20:1 to 50:1	Automatic Scrubbers Soil dependant

DIRECTIONS

As a spot cleaner on rubber tire marks:

Dilute **Skid-Daddle** 1:1 with water and spray or pour directly on the marks. Allow the solution to soften the tire mark for at least 15 minutes and then scrub the area. Rinse well with clean water.

As a bucket cleaner:

Dilute **Skid-Daddle** 10:1 with water.

In automatic scrubbers:

Dilute **Skid-Daddle** 20:1 to 50:1 with water depending on how heavily soiled the area is.

NOTE:

*Rinse well. Completely remove **Skid-Daddle** from the surface of the substrate.*

CLEANUP

Clean tools and equipment with clean water.

STORAGE

Store in tightly sealed containers in a cool dry area away from direct sunlight and sources of heat. Shelf life of properly stored material is two years from date of manufacture.

LIMITATIONS

- A test area is recommended. This is especially important if the exact chemistry of the floor sealer or coating is unknown. Apply **Skid-Daddle** diluted 1:1 with water to a 1ft²(0.3m²) area and scrub. If any deterioration of the coating or sealer is noticed or if the surface loses its sheen contact ChemMasters' Technical Service Department for alternative recommendations.

Precautions:
